WILL THE OLD COOP BAKERY BUILDING BE DEMOLISHED?



RECORD NUMBERS ENJOY FIREWORK EVENT



West Lothian Council have made it clear that demolition is the likely option if there is no appetite from the community to take it on in some form. No buyer has been found for the building, which is an ongoing cost to an already cash strapped Council. The Cooperative is a major part of our West Calder & wider Five Sisters Communities heritage. Many of us remember our, or indeed a relative's, "divi number" or someone who worked there. The future of the Old Bakery Building has been raised again and again since The Workspace closed its doors.

Now we need, as a Trust and as a community, to move towards a decision as to whether or not to try and redevelop it.

In the 2013-18 Community Action Plan Theme 5 (under Developing an Enterprising Community) identifies as a priority:

"A big new project to underpin the revival of the community 'Destination West Calder' and suggested we draw up a brief for an Urban Realm Study; approach a range of consultants and develop imaginative ideas and options for the use of our public buildings and outside spaces."

The Urban Realm Design Study produced in 2013 showed a project developing the Workspace/Bakery as the second most important project, jointly with improving Main Street, and following improvements to Union Square, according to community feedback. A range of potential uses were suggested by the community and were presented by the consultants for feedback.

IS IT POSSIBLE TO COMBINE A PROJECT AIMED AT MAKING WEST CALDER A DESTINATION AND REDEVELOPMENT OF THE OLD BAKERY BUILDING?

In the Summer of 2017 The Council requested that the community give a formal but non-binding expression of interest by the end of 2017. This would allow the start of negotiations and take the building off the market. The Trust commissioned a physical building survey (condition and structure) and indicative costings for both improvement and demolition. In order that we know what we were potentially dealing with, the results in a nutshell, it is structurally pretty good and capable of being converted to pretty much anything the community has so far suggested but it will cost up to £1million to turn into a good clean, dry and sound shell ready for redeveloping. Following on from this we have hired consultants Community Enterprise to conduct a community consultation and business feasibility study to see if any of the ideas are viable and whether there is enough community buy-in for such an ambitious project.

So far, at time of writing, the response has been highly positive towards the idea of at least further investigation but these have been primarily online responses and perhaps the paper surveys will bring the views of a different demographic to light. There have also been concerns raised including, for example, the sheer cost and risk of such a project, potential displacement (taking trade away from other businesses and venues), the management structure required and traffic and parking.

In order to keep our options open into 2018, the board of trustees has submitted this expression of interest on behalf of the community – which is a non-binding commitment – but effectively takes the property “off the market” while discussions and consultations continue.

There is a lot more opinion, and many more ideas, to be gathered over the next while and there will be public events and discussion groups as well as, yet more, consultations (including the full results of the current surveys). It is important to remember that this is just the first stages of a long process and no decisions have been taken and will not be without wide community engagement.

What is Community Asset Transfer?

Community Asset Transfer is where a community organisation makes a request to take control of an “asset”, a building for example, that is owned by a public body, like the Council for example. They may do so because the building is at risk, is lying undeveloped or just because the community believes they can offer a better service themselves.

The “asset” can be sold, sold at a discount, given for free or taken on a long term lease. There are many options depending on the nature of the “asset”, the level of community benefit and the plans for the future of it.

This process is supported by the recent Community Empowerment Act introduced by the Scottish Government.

FIVE SISTERS SKATEPARK UPDATE

Plans are still on track to build a new skatepark between the new West Calder High School and Parkhead Primary in time for the new school opening in Summer 2018. A designer/contractor has been chosen and following a session for the public at The Trust Open Day, in September 2017, a design has been finalised. We have raised £93,000 to date and aim for another £40,000 with funding applications currently being prepared.

TRUST OPEN DAY


The Trust Open Day in Sept was aimed at letting people know what it is that The Trust does, and has been doing. We had a fantastic turnout but one more that not everyone in our community knows who, what or why we are. We presented our history since incorporation as a timeline which you can see below. We hope it shows many things but importantly that The Trust was created out of an initiative of the Community Council to create a community controlled body that could negotiate for and receive windfarm funds on behalf of the community and to apply for more from elsewhere to deliver the aims of the Community Action Plan.

We hope it also shows that the funds from the windfarms didn't actually come in stream until summer last year which, after five years of bidding up, we, when there was a bit of an explosion of activity. It confirms what we all know; you need time, people and some money to get stuff done!

The funding from windfarms is generous but not exhaustive. Funding has been raised from many other sources for specific projects — in fact it is the capacity to do this that is one of the most important things that the windfarms money has bought.

There is no huge pot of millions waiting for us to spend. There is a decent chunk we can use to seed projects and there is what we manage to raise. What we raise money for is ultimately up to the community and our trust members and the best way to let us know your opinion is just to tell us. Or become a member, everyone is welcome.



PUBLIC ART PROJECT - ARTIST COMMISSIONED

Kate said: "I am delighted to have been awarded this project and am looking forward to working with many different groups from the villages to develop art that will really say something meaningful and positive about your communities".

Kate Ivey is an Edinburgh-based artist and works from her studio at Edinburgh Sculpture Workshop. She has created a number of notable artworks, including for the Helensburgh Dundee Museum, the City of Edinburgh Council's Promenade, Falkland Conservation Park in Fife and a number of sculpture commissions for Scottish Government campaigns. Kate is currently lead artist for the Art & Therapeutic Design Project 'Gift to New' for the new hospital being built in Edinburgh.


